FRANCHISE OVERVIEW:

Based in Ventura, California, the Ventura County Fusion is a world-class, championship-caliber soccer franchise and participant in the Western Conference's Southwest Division of the Premier Development League (PDL), an official operation of United Soccer Leagues (USL). Now in its eighth year of operation, the team recently concluded yet another banner season in 2014, winning the Southwest Division title, reaching the 2nd Round of the US Open Cup, and defeating Scotland's famed Rangers FC (Glasgow, Scotland).

The Fusion's roster annually consists of members of the U.S.'s Under 20 National Team, players from well-respected NCAA Division I university programs, and highly touted youth internationals from throughout the world. In addition to PDL play, the Fusion has competed in the Lamar Hunt U.S. Open Cup each of the last five seasons, and in various exhibitions against some of the world's best professional squads, including Manchester City, Everton FC, Burnley FC, Portsmouth FC, Swansea City and West Bromwich Albion of the English Premier League, and a dozen Major League Soccer (MLS) franchises including the Los Angeles Galaxy, Seattle Sounders & DC United.. The Fusion is one of the few PDL organizations to offer a broad range of soccer instructional programs, including camps, schools, free clinics, and a youth club academy, specifically designed for players of different experience levels.
